# Capego SmartSign Compliance



For us security and compliance are important. Capego SmartSign in collaboration with Criipto is fully compliant with eIDAS - meaning that all documents are digitally signed in accordance with the eIDA standad.

EU has presented a list of rules and requirements to secure the online activity in the EU. To ensure security all our services comply with the strict rules and regulations and are regularly controlled by specialists to ensure that they always meet the strict requirements.

## eIDAS Regulation

By doing the eIDA, EU has managed to create a foundation and legal framework to ensure businesses and others a safe access to services and safe online transactions. The eIDAS Regulation on electronic identification and trust services helps businesses and others with secure and seamless electronic interactions. eIDA ensures higher security and more convenience for online activities.

According to the European Commission (2023) the eIDAS Regulation:

- ensures that people and businesses can use their own national electronic identification schemes (eIDs) to access public services available online in other EU countries;
- creates a European internal market for trust services by ensuring that they will work across borders and have the same legal status as their traditional paper-based equivalents.

Capego SmartSign using eID is compliant with:

- PAdES standard
- ETSI 319 142
- eIDAS

**PAdES** (PDF Advanced Electronic Signatures) enables advanced electronic signatures and is regulated by the ETSI EN 319 142 standard. PAdES specifies precise profiles, making it compliant with the ETSI standard for digital signatures.



**ETSI** (European Telecommunications Standards Institute) has the function of issuing technical standards by delegation in the EU eIDAS Regulation. eIDAS is a European regulation that consists of two parts. One regulates electronic identification (eID) and the other regulates additional services (AS). The purpose behind the eIDAS is to achieve a satisfying security level for electronic identification and its additional services.

**eIDAS** is legally binding in all EU member states. It is directly applicable without implementing or interpreting legislation. The ETSI 319 142 standard for PAdES is built according to the eIDAS regulation. By using PAdES certification on a signature, the signature is according to the eIDAS regulation and ETSI technical standards.

By using our service and signing with an electronic identity provider such as BankID the signature will be classified as **Advanced electronic signatures (AES)** - these are electronic signatures that meet certain requirements such as being uniquely linked to the signatory, capable of identifying the signatory, and created using means that the signatory can maintain under their sole control.
